Consequent to the orders issued in para-1 above, the existing post of Financial Controller/Coal/Chennai shall be re-designated as Financial Controller/Coal and Coal Handling/Chennai and the works hitherto attended by the Financial Controller/Coal Handling shall be attached to the Financial Controller/Coal and Coal Handling.

3. The incumbent of the post ordered in para-1 above will be eligible to draw the usual pay, Dearness Allowance, House Rent Allowance, City Compensatory Allowance and other allowances at the rates admissible under the orders in force wherever applicable.

4. The expenditure is debitable to “TANGEDCO Funds – Revenue Expenses – 75 – Employees costs 75.1 – Salaries–75.110 – Salaries Provincial”.
