**Memorandum No.13806/A18/A181/2020-4, dated the 20<sup>th</sup> November, 2020.**

Sub:TANGEDCO – Grant of Notional increment to the officers/employees who retire on superannuation on the preceding day of increment due date – Orders issued – Applicability of the orders to those who voluntarily retire from TANGEDCO's Service – Clarification – Issued.

Based on the Government Order first cited, instructions were issued to the effect that an officer/employee of TANGEDCO whose increment falls due on the day following superannuation, on completion of one full year of service, be sanctioned with one notional increment, for the purpose of Pensionary Benefits – vide Proceedings second cited. In the proceedings third cited, necessary amendments to regulation 36 of TNEB Service Regulations were issued. The Government in its order fourth cited, have issued orders, extending the benefit of sanction of annual increment to those who retired prior to 31.12.2014 and completed one full year of service prior to their retirement, notionally with effect from the date of their retirement for the purpose of revision of pension with monetary benefit prospectively with effect from 31.12.2014. The same has been adopted in TANGEDCO - vide Board's Proceedings fifth cited. Certain Chief Engineers/Superintending Engineers have sought for clarification as to whether the said order can be made applicable for the officers/employees who voluntarily retire from TANGEDCO's service. Necessary clarifications have been obtained from the Government. Accordingly, it is clarified that the officers/employees who retire from TANGEDCO's service voluntarily shall not be eligible for the benefit granted in Proceedings second, third and fifth cited.

**2.** All the Chief Engineers/Superintending Engineers and the Chief Internal Audit Officer are directed to follow the above instructions scrupulously in future.

**3.** The receipt of the Memo. shall be acknowledged.


